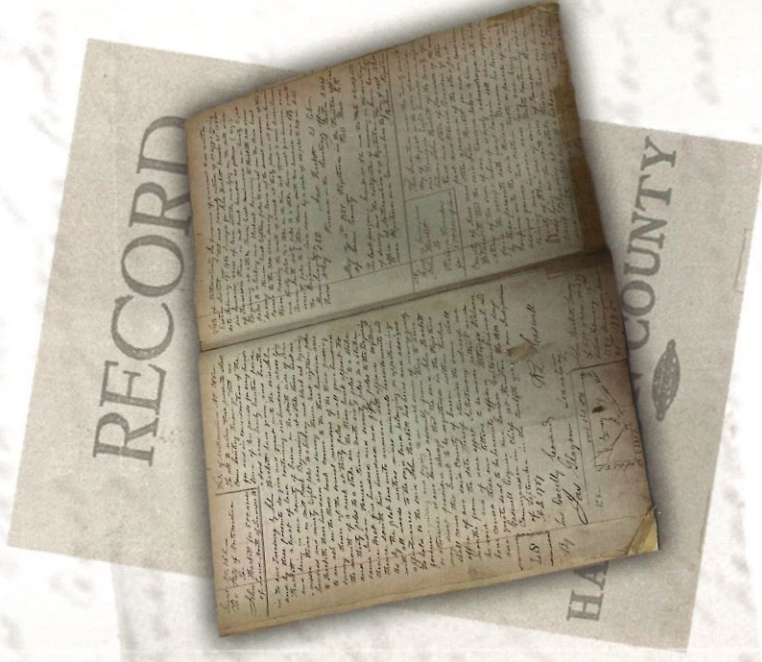
## Need A Copy Of Your Deed?

**Veterans DD214's Recorded At No Cost:**

Veterans can record their original DD214 at **NO CHARGE**.

Must be an original or certified copy, and reflect the type of discharge to be recorded, i.e. Honorable, Medical, etc.

**Under T.C.A. § 10-7-513**, military discharge records are confidential for 75 years from the date they are recorded in our office.

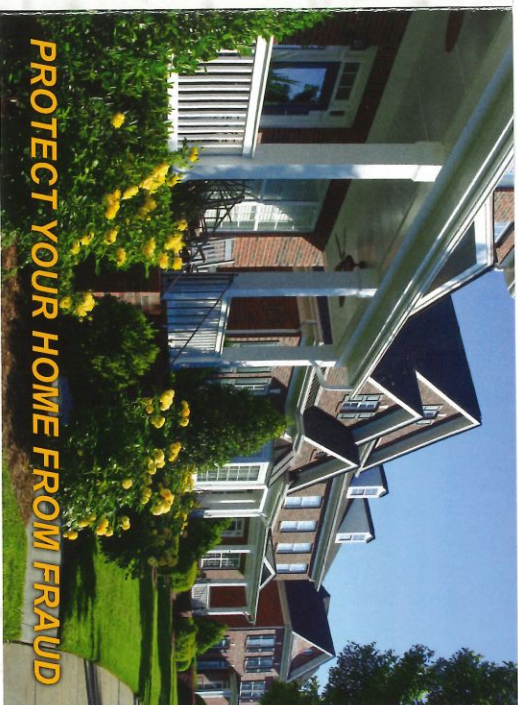

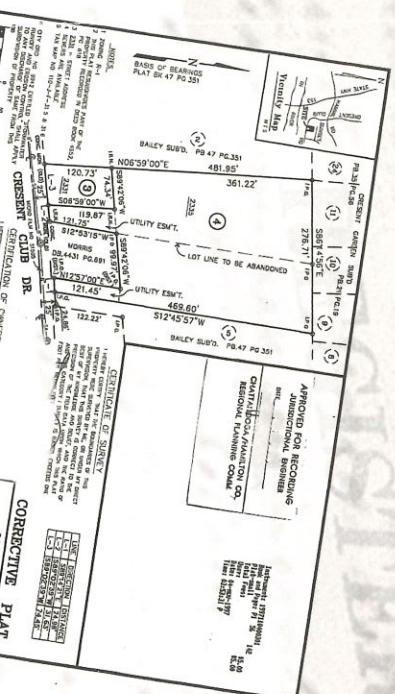
